# The London Legacy Development Corporation and Olympic Delivery Authority Transfer Scheme (3) 2013

The Secretary of State, in exercise of the powers conferred by section 200(1) and section 218 of the Localism Act 2011, having consulted the Olympic Delivery Authority and the Mayor of London, makes this Transfer Scheme.

## Interpretation

1. In this Transfer Scheme-

"the Act" means the Localism Act 2011;

"LLDC" means London Legacy Development Corporation; and

"ODA" means Olympic Delivery Authority.

### **Transfer date**

2. The transfer date is 1 August 2013.

### Transfer of property, rights and liabilities of ODA to LLDC

- 3. Subject to the provisions in paragraph 4 below, on the transfer date all property, rights and liabilities of ODA under the agreements set out in the Schedule are transferred to LLDC.
- 4. Notwithstanding the provisions of paragraph 3 above, in respect of the agreement in item 20 of the Schedule the following provisions of that agreement are not transferred to LLDC:
  - 4.1 Clause 1.1 (a)
  - 4.2 Clause 1.2.1 (a)
  - 4.3 Clause 3.2
  - 4.4 Clause 4.1
  - 4.5 Clause 4.6 (b)
  - 4.6 Clause 5.1
  - 4.7 Clause 5.2
  - 4.8 Clause 6.1
  - 4.9 Clause 8.3
  - 4.10 The following definitions:

"Existing SVDP Deed of Easement"

"Existing SVDP Substation Lease"

"HS1 Deed of Easement"

"LVU Agreement"

"LVU Management Agreement"

"New Concession Agreement"

"SVDP Assistance Third Party Land"

- 4.11 In clause 8.1, the reference to "Clause 8.3"
- 4.12 In each of the following definitions, the parts of them referred to below:

"Development Agreement" - sub-paragraph (a)

"Employers Decision" – sub-paragraph (a)

"Reserved Decision" – sub-paragraph (a)

"Utilities Agreements" - the reference to "the LVU Agreement" and the reference to "electricity"

4.13 The remaining provisions of the agreement to the extent that they relate to the LVU Agreement and the LVU Management Agreement as defined.

### Transitional, supplementary and incidental provision

- 5. Anything done (or having effect as if done) before the transfer date by or in relation to ODA in respect of anything transferred by this scheme, has effect on and after that date as if done by or in relation to LLDC.
- 6. Anything which, before the transfer date is in the process of being done by, on behalf of, or in relation to ODA in respect of anything transferred by this scheme (including legal proceedings) may be continued on and after that date as if done by, on behalf of, or in relation to LLDC.
- 7. Any reference to ODA in an instrument or other document in respect of anything transferred has effect on and after the transfer date as a reference to LLDC in so far as it relates to anything transferred.
- 8. A reference in paragraphs 4 to 6 to anything transferred by this scheme applies to any property, right or liability transferred, whether or not identified specifically in the scheme.
- 9. A certificate issued by the Secretary of State will be conclusive evidence that that property has transferred to LLDC.
