

The London Legacy Development Corporation and Olympic Delivery Authority

Transfer Scheme 2012

The Secretary of State, in exercise of the powers conferred by section 200(1) and section 218 of the Localism Act 2011, having consulted the Olympic Delivery Authority and the Mayor of London, makes this Transfer Scheme.

Interpretation

1. In this Transfer Scheme-

"the Act" means the Localism Act 2011;

"ODA" means Olympic Delivery Authority;

"LLDC" means London Legacy Development Corporation; and

Transfer date

The transfer date is 30th September 2012.

Transfer of property, rights and liabilities of Olympic Delivery Authority to the LLDC

- 3. -(1) On the transfer date, all property, rights and liabilities of ODA, specified in paragraph (2) and the contracts of employment specified in paragraph (9), are transferred to the LLDC.
- (2) The property, rights and liabilities referred to in paragraph (1) include-
 - a. the assets specified in Schedule 1A;
 - b. the rights and liabilities under the contracts specified in Schedule 1B;
 - c. the records and data specified in Schedule 1C;
 - d. the rights and liabilities under the Asset Protection Agreement and Bridge Agreements specified in Schedule 1D;
 - e. the rights and liabilities relating to the planning agreements specified in Schedule 1E;

Transitional, supplementary and incidental provision

- 4. Anything done (or having effect as if done) before the transfer date by or in relation to the ODA in respect of anything transferred by this scheme, has effect on and after that date as if done by or in relation to the LLDC.
- 5. Anything which, before the transfer date is in the process of being done by, on behalf of or in relation to the ODA in respect of anything transferred by

this scheme (including legal proceedings) may be continued on and after that date as if done by or in relation to the LLDC.

- Any reference to the ODA in an instrument or other document in respect of anything transferred has effect on and after the transfer date as a reference to the LLDC, including the membership or share of any company or limited liability partnership.
- 7. A reference in paragraphs 4 to 6 to anything transferred by this scheme, applies to any property, right or liability transferred, whether or not identified specifically in the scheme.
- 8. A certificate issued by the Secretary of State will be conclusive evidence that that property has transferred to the LLDC.

Transfer of posts and employees of the Olympic Delivery Authority

 On the transfer date, the rights and liabilities under the contracts of employment of the individuals employed by ODA the staff numbers of which are specified in Schedule 1F are transferred to the LLDC along with all associated records and files.


